THE RESIDENCY PROGRAM PROVIDES CUSTOMIZED VISUAL ARTS INSTRUCTION THAT SERVES DESIGNATED CLASSES, OFFERS SPECIFIC ART MEDIA, OR ADDRESSES THE NEEDS OF PARTICULAR STUDENTS, SUCH AS MULTILINGUAL LEARNERS OR STUDENTS WITH DISABILITIES. RANGING FROM 6 TO 20 WEEKS, RESIDENCIES SERVE STUDENTS BOTH DURING AND AFTER SCHOOL. STUDIO ARTIST INSTRUCTORS PROVIDE HANDS-ON VISUAL ART INSTRUCTION FOR STUDENTS AS WELL AS TEACHER AND FAMILY ENGAGEMENT IN THE VISUAL ARTS. DUE TO THE PANDEMIC IN 2020, INSTRUCTION SHIFTED TO VIRTUAL PLATFORMS. IN 2019-20, THE RESIDENCY PROGRAM SERVED 13,900 STUDENTS IN 241 RESIDENCES IN PARTNERSHIP WITH 124 PARTNER SITES IN ALL NYC BOROUGHES.

THE LONG TERM PROGRAM ESTABLISHES SEQUENTIAL, STANDARDS-BASED VISUAL ARTS CURRICULUM IN NYC PUBLIC SCHOOLS WHICH LACK VISUAL ARTS INSTRUCTION. PARTNER SCHOOLS HAVE TITLE I STATUS, MAKE A 5-YEAR COMMITMENT, AND DEDICATE A SPACE FOR THE ART STUDIO. THROUGH INSTRUCTION ACROSS GRADES IN DIVERSE ART MEDIA, PROFESSIONAL DEVELOPMENT AND FAMILY WORKSHOPS, AND SCHOOL-WIDE EXHIBITIONS, THE ARTIST INSTRUCTOR EMBEDS THE VISUAL ARTS INTO THE CURRICULUM AND CULTURE OF THE SCHOOL. THE PROGRAM WORKS WITH 25 SCHOOLS CITYWIDE EACH YEAR, SERVING UP TO 9,000 STUDENTS AND 500 TEACHERS. IN MARCH 2020, DUE TO THE PANDEMIC, ALL INSTRUCTION MOVED TO A DIGITAL LEARNING STRATEGY.
